Lave Sharma S/o Sh. Gyanendra Sharma), पोल सं० 3001022899- सेड SL/251 प्रेसि जी.बी.सी. की जे.जे.सि. (पुन-सी) को यह पर नियमित/नियमित नियमनो और जारी दिनांक 06.09.2024 (पूर्वार्ध) को पूर्णतः अस्थाई नियुक्ति की जाती है। उपर्युक्त नियुक्ति कार्य कार्यालयक अभियन्ता, बी मण्डल, कोलॉनियल, आई.पी. भवन, नई दिल्ली कार्यालय के अध्यक्षकाल को जारी है:-

- The scale of pay admissible to the post of LDC will be in level-2 under 7th CPC in the pay matrix level-2, cell-1 of CCS (RP) Rules, 2016 with a basic pay of Rs. 19900/- per month plus u allowance (as admissible). However, no travelling allowance (for joining at place of post) shall be admissible.
- He shall be placed under new pension scheme, 2004 of Govt. of India. As per Govt. of India, Finance notification no. 5/7/2003-ECV&PR dt. 22.12.2003 and as amended from time to time.
- He shall have to furnish, within four weeks from the date of appointment the following details:
 - Details of their movable and immovable property.
 - Home town declaration for LTC purpose.
 - Family details in form-3.
 - Declaration regarding marriage.
 - Oath of allegiance and faithfulness to Govt. of India.
 - Oath secrecy as prescribed under the official secrets act, 1923.
- He will be on probation for a period of two years from date of appointment and the period may extended at the discretion of the competent authority.
- The appointment will further be subject to him taking an oath of allegiance/fidelity to Constitution of India or making solemn affirmation to that effect in the prescribed form. On conditions of service will be governed by the relevant rules and orders in force applicable to govt. employees from time to time.
- If any declaration given or information furnished by him proves to be false or if he is found have willfully suppressed any material information, he will be liable to be dismissed from service and such other action as govt. may deem necessary.
- His appointment is subject to verification of the following documents:-
 - Character and antecedents verification by the Police Authority.
 - Verification of Schedule Caste/Schedule Tribes/EWS certificate issued by the competent authority (if applicable).
 - Verification of certificate indicating date of birth.

- (d) Verification of certificate and testimonials in support of his educational qualification as on date indicated in recruitment notice published by SSC.
- (e) Verification of valid income certificate of EWS candidate (if applicable).
- (f) A discharge/reieving certificate in case he is employee in other organisation prior to joining department.
- (g) Character certificate from a first class magistrate or from two gazette officers who is know him for the last three years but not related to him duly attested by the first class executive magistrates before joining duty.
- (h) Documentary proof issued by the competent authority in support of age relaxation claimed him, if any.
- (i) OBC certificate indicating non-creamy layer status issued by the prescribed authority where applicable.
- (j) If the verification reveals that the claim of belonging to Schedule Caste/Schedule Tribe/D certificate and mandatory educational qualification certificate as the case may be, is false/f then the services shall be terminated forthwith without assigning any without prejudice to v further action as may be taken under the provisions of the Indian Penal Code for the production false certificate. (Govt. of India Department of personnel and training officer order 36011/3/2005-Estt./Res.) dated 09.09.2005.
8. In case it is proved after the acceptance of offer appointment that he is dismissed employee of union or state govt. disqualifying him for further employment under govt. or that he has usual employment by deceit he will be dismissed from service without any remuneration.
9. The candidate's services are liable to be terminated on one month's notice from either s namely the appointee and appointing authority in accordance with CCS (temporary) service r 1965 without assigning any reasons. The govt. however, reserves the right of termination candidate's service forthwith or before the expiry of the stipulated period of notice by mak payment of a sum equivalent to the pay and allowance for the period of notice of the unexp portion thereof.
10. On his assumption of duty, he must apply to the Estate Officer for Govt. Accommodation in prescribed form (wherever it exist) within a week in order to be eligible to draw house r allowance as admissible under the rule (in the event of such accommodation being not availa falling which on house rent allowance will be paid to him).
11. He will not leave the department on an offer being received from any other department where might have applied before being nominated here, without taking prior permission from department. Also he will not apply directly for any post outside the CPWD.
12. The candidate is required to undergo mandatory foundation training of six weeks after joining respective place of posting in CPWD. The nomination for four-basis training necessary shall done by O/o SE (Regional Training Institute, Delhi), R.K. Puram, New Delhi. They m successfully complete the foundation training and pass the examination and tests to be conduct during and/or at the end of the training as a pre-condition to satisfactory completion of probatio

There shall be no exemption from the foundational training for the newly recruits as a However, in case a candidate fails to undergo the foundation training then he must complete training with the next batch. Further, no claim for cleaning probation without completion foundation training due late joining shall be consistent.
14. In accordance with the relevant rules in force in regard to the recruitment to the service under Govt. of India, if any declaration or information furnished by the candidate proves to be false candidate is found to have willfully suppressed and material information, then candidate shall be liable to be removed from service and to any such other action as the govt. may deem fit.
15. Employed candidate shall have to submit a discharged certificate from the last employer already employed with some other govt. department.
16. The appointment carries within the liability to serve in any part of India.
